## AFFIDAVIT FOR SEARCH WARRANT

THE UNDERSIGNED PERSON, BEING DULY SWORN UPON HER OATH, DEPOSES AND STATES AS FOLLOWS:

This search warrant affidavit applies to the following records and evidence limited to the time frame of January 1, 2011 through October 8, 2019:

- (1.) All stored communications and other files reflecting communications to or from saunderscarina@yahoo.com;
- (2.) All files that have been accessed by saunderscarina@yahoo.comor are controlled by user accounts associated with saunderscarina@yahoo.com;
- (3.) All logs and records of user activity for saunderscarina@yahoo.com, including;
  - 1. Contents of Yahoo Photos, to include all albums, photos, videos, and metadata for each file;
  - 2. Content of all Yahoo posts and/or comments associated with the account, as well as a copy of the Yahoo profile and Yahoo contacts;
  - 3. All files/folders present in the user's Yahoo Drive;
  - 4. YouTube subscriber information, copies of videos and associated metadata, and any YouTube comments or private messages;
  - Copies of Yahoo mail;
  - Copies email content as per usual;
  - 7. Copies of any messages sent with Yahoo Messenger and any chat logs;
  - Copies of any blogs, comments, or posts to blogs;
  - For the target account(s), provide the Android/iPhone device information, including IMEI/MEID, make and model, serial number, date and IP of last access to Yahoo, and a list of all accounts that have ever been active on the device.
- (4.) All subscriber information provided to Yahoo, to include, but not limited to, name, address, gender, age, and occupation, for the email address saunderscarina@yahoo.com;

FURTHER, YOUR AFFIANT STATES, IN SUPPORT OF THIS APPLICATION AND FOR SHOWING THAT THERE IS PROBABLE CAUSE FOR THE ISSUANCE OF A SEARCH WARRANT, AS FOLLOWS:

THAT, your affiant is Meghan Bowman, a certified and commissioned peace officer in and for the State of Oklahoma and is currently employed as a Special Agent for the Oklahoma State Bureau of Investigation (OSBI). Your affiant has been in Law Enforcement for approximately 4.5 years, working major felony criminal investigations for the OSBI. Your affiant's training and education has included a Bachelor Degree in Accounting from the University of Oklahoma; the State of Oklahoma Basic Peace Officer Academy; and the OSBI Agents Academy.

THAT, on October 13, 2011, the body of CARINA SAUNDERS was found behind a homeland store in Bethany, Oklahoma County, Oklahoma. Her death was ruled a homicide by the Oklahoma Medical Examiner's Office. In April of 2013, the Oklahoma State Bureau of Investigation was requested to investigate the death.

THAT, on January 30, 2019, your affiant was assigned the case. Your affiant reviewed the materials in the case and performed interviews and investigative activities.

THAT, on September 27, 2016, OSBI Special Agent JIM ELY served a search warrant to Facebook and received SAUNDERS' Facebook records. On October 1, 2019, Your Affiant reviewed SAUNDERS' Facebook records and found the following:

THAT, on August 15, 2011, SAUNDERS told HAILEY RADLER via Facebook Messenger she had been beat up by two guys approximately a week or two prior. SAUNDERS told RADLER that she could text from her yahoo account. RADLER told SAUNDERS to text RADLER'S mom through yahoo, so RADLER'S mom could come pick SAUNDERS up.

THAT, on September 26, 2019, SAUNDERS was making plans to meet up with DAVID CARSON. SAUNDERS told CARSON through Facebook messenger "gimee ur number n ill text u from my yahoo account".

THAT, on September 26, 2019, SAUNDERS messaged ISAAC ALVAREZ on Facebook. SAUNDERS told ALVAREZ that she texted him from her yahoo account because she did not have a phone.

THAT SAUNDERS email account, had vahoo reaistered a saunderscarina@yahoo.com, on her Facebook account.

THAT, based on my training and experience, I know that pictures and video files can remain indefinitely on digital storage devices or in online "cloud" storage accounts until deleted or overwritten. I also know a suspect may try to conceal criminal evidence, and he or she might store criminal evidence in random order with deceptive file names. This may require searching authorities to examine all the stored data to determine which particular files are evidence or instrumentalities of crime. This sorting process can take weeks or months. depending on volume of data stored.

THAT, the undersigned affiant submits based on the facts set forth in this affidavit, that there is probable cause to believe that the Yahoo Account was used for Murder, Oklahoma Statute Title 21, Chapter 24, Section 701.7.

THAT, The statements in this Affidavit include information provided by witness testimony. Since this affidavit is being submitted for the limited purpose of securing a search warrant, I have not included each and every fact known to me concerning this investigation. I have set forth only the facts that I believe are necessary to establish probable cause to support the issuance of a search warrant.

THAT, Based upon the above-described facts, Your Affiant respectfully requests that a search warrant be issued to Yahoo Oath Holdings located at 701 94089. Sunnyvale, CA Avenue. for the Yahoo saunderscarina@yahoo.com, and the items listed above in sections 1 through 4.
