### **EXAMINATION RESULTS – NO DECEPTION INDICATED (passed)**

**REPORT:** On July 23, 2020 I conducted a specific-issue polygraph examination with Jimmy Massey. Before the test began, I asked Mr. Massey a series of medical questions to determine his suitability for taking a polygraph test. According to his answers to these medical questions and my observations of Mr. Massey, I determined that he was suitable for a polygraph test. Mr. Massey read and signed a form advising him of his rights concerning the taking of a polygraph test in the State of Oklahoma. This form also states that the examinee hereby releases the examiner administering this examination, Kyle Franks, and Accurate Solutions Incorporated, Griffin Communications, News 9, and employees of News 9 from any and all claims resulting from or arising out of this examination.

This polygraph examination concerned the allegations of murder, participating in murder, and the direct knowledge of who was the murderer in the Carina Saunders case from October 13, 2011. Mr. Massey has been accused of being involved in the death of Ms. Saunders by either killing her, participating in the killing of her, or having direct knowledge of who the killer was. Mr. Massey denied all allegations of being involved with the Carina Saunders case.

All questions that were asked during the actual data collection phase of this test were reviewed and discussed in detail with him prior to the test beginning. He answered all of the questions and said that he understood them.

The relevant questions asked on the test are listed below with Mr. Massey's answers:

1. Did you cause the death of Carina Saunders? (Answer "no")
2. Regarding the death of Carina, did you participate in anyway? (Answer "no")

3. Do you know for sure who caused the death of Carina Saunders? (Answer “no”)

Note\*

- The term “cause the death” was pre-test described as the killing of Carina Saunders.
- The term “participate” was described prior to the test as helping, planning, or participating in anyway in the killing of Carina Saunders. This included: assisting with the disposal or hiding of the body, cutting up body parts, placing body parts in a duffle bag, ordering the killing of, witnessing the killing, video-taping the killing, tying up or kidnapping of Carina Saunders.
- The term “knowing for sure” was pre-test described as having direct knowledge of identity of the killer of Carina Saunders.

Five charts were conducted in a specific issue UTAH-Zone validated format. The exam contained the above relevant questions on all charts. Mr. Massey’s physiological reactions, as recorded on the polygraph charts, are **no deception indicated** when he answered the relevant questions. If you are considering taking any punitive action against Mr. Massey based on the information contained in this report, please contact me to verify the information before any such action is taken.
