COUNT

1: ON OR ABOUT THE 5TH DAY OF AUGUST, 2011, A.D., THE CRIME OF TRAFFICKING IN
ILLEGAL DRUGS WAS FELONIOUSLY COMMITTED IN OKLAHOMA COUNTY,
OKLAHOMA, BY JIMMY LEE MASSEY JR, ALEJANDRO ROJAS, FRANCISCO GOMEZ,
EDGAR ALBERTO GONZALEZ-OLIVAS, AND LUIS ARTURO SOTO, WHO ACTING
CONJOINTLY, DID KNOWINGLY POSSESS NOT LESS THAN TWENTY (20) GRAMS OF
METHAMPHETAMINE, WHICH IS CLASSIFIED AS A CONTROLLED DANGEROUS
SUBSTANCE IN SCHEDULE II OF THE CONTROLLED DANGEROUS SUBSTANCE ACT OF
THIS STATE, CONTRARY TO THE PROVISIONS OF SECTION 2-415 OF TITLE 63 OF THE
OKLAHOMA STATUTES, AND AGAINST THE PEACE AND DIGNITY OF THE STATE OF
OKLAHOMA

2: ON OR ABOUT THE 5TH DAY OF AUGUST, 2011, A.D., THE CRIME OF CONSPIRACY TO
TRAFFIC A CONTROLLED DANGEROUS SUBSTANCE WAS FELONIOUSLY COMMITTED IN
OKLAHOMA COUNTY, OKLAHOMA, BY JIMMY LEE MASSEY JR, ALEJANDRO ROJAS,
FRANCISCO GOMEZ, EDGAR ALBERTO GONZALEZ-OLIVAS, AND LUIS ARTURO SOTO,
WHO ACTING CONJOINTLY, WILLFULLY, KNOWINGLY, AND FELONIOUSLY ENTERED
INTO A CONSPIRACY TO TRAFFIC A CONTROLLED DANGEROUS SUBSTANCE,
SPECIFICALLY: METHAMPHETAMINE, AND IN FURTHERANCE THEREOF DID COMMIT
THE FOLLOWING OVERT ACT: BY ON OR ABOUT THE FIRST WEEK OF OCTOBER 2011,

DANGEROUS SUBSTANCE ACT OF THIS STATE, CONTRARY TO THE PROVISIONS OF
SECTION 2-408 OF TITLE 63 OF THE OKLAHOMA STATUTES, AND AGAINST THE PEACE

3: ON OR ABOUT THE 4TH DAY OF NOVEMBER, 2011, A.D., THE CRIME OF MAINTAINING A
DWELLING HOUSE WHERE A CONTROLLED DANGEROUS SUBSTANCE WAS KEPT WAS

FELONIOUSLY COMMITTED IN OKLAHOMA COUNTY, OKLAHOMA, BY EDGAR ALBERTO GONZALEZ-OLIVAS, WHO KNOWINGLY MAINTAINED A DWELLING HOUSE, LOCATED AT 2533 SOUTHWEST 28TH, WHERE METHAMPHETAMINE, A CONTROLLED DANGEROUS SUBSTANCE, WAS KEPT, CONTRARY TO THE PROVISIONS OF SECTION 2-404 OF TITLE 63 OF THE OKLAHOMA STATUTES, AND AGAINST THE PEACE AND DIGNITY OF THE STATE OF OKLAHOMA

- 4 : ON OR ABOUT THE 4TH DAY OF NOVEMBER, 2011, A.D., THE CRIME OF POSSESSION OF A CONTROLLED DANGEROUS SUBSTANCE WAS FELONIOUSLY COMMITTED IN OKLAHOMA COUNTY, OKLAHOMA, BY EDGAR ALBERTO GONZALEZ-OLIVAS, WHO WILLFULLY, KNOWINGLY, OR INTENTIONALLY HAD WITHIN HIS POSSESSION A QUANTITY OF HYDROCODONE AND XANAX, CLASSIFIED AS A CONTROLLED DANGEROUS SUBSTANCES IN SCHEDULE III AND IV OF THE CONTROLLED DANGEROUS SUBSTANCE ACT OF THIS STATE, CONTRARY TO THE PROVISIONS OF SECTION 2-402 OF TITLE 63 OF THE OKLAHOMA STATUTES, AND AGAINST THE PEACE AND DIGNITY OF THE STATE OF OKLAHOMA



- 5 : ON OR ABOUT THE 4TH DAY OF NOVEMBER, 2011, A.D., THE CRIME OF POSSESSION OF DRUG PARAPHERNALIA WAS UNLAWFULLY COMMITTED IN OKLAHOMA COUNTY, OKLAHOMA, BY EDGAR ALBERTO GONZALEZ-OLIVAS, WHO WILLFULLY, KNOWINGLY, AND WITHOUT LAWFUL NEED HAD WITHIN HIS POSSESSION PARAPHERNALIA USED BY ABUSERS OF CONTROLLED DANGEROUS SUBSTANCES FOR ADMINISTERING SAID SUBSTANCES, SPECIFICALLY: SMOKING PIPES, SCALES, AND A GRINDER, CONTRARY TO THE PROVISIONS OF SECTION 2-405 OF TITLE 63 OF THE OKLAHOMA STATUTES, AND AGAINST THE PEACE AND DIGNITY OF THE STATE OF OKLAHOMA
