BODY OF REPORT:

ON 10/10/11 AT AROUND 0945 HOURS I RECEIVED A CALL TO 1443 E. EUCLID ST. IN REFERENCE TO A MISSING PERSON.

WHEN I ARRIVED A SPOKE WITH RP WHO IS MP'S MOTHER AND IP WHO IS MP'S COUSIN. RP STATED HER DAUGHTER HAD NOT BEEN SEEN OR HEARD FROM IN SEVERAL WEEKS. IP STATED SHE ALLOWED MP TO STAY AT HER HOUSE FOR APPROXIMATELY A WEEK. [REDACTED]

ON 09/28/11 IP TOOK MP TO I 40 AND N. ROCKWELL AV. WHERE MP MET A WHITE MALE APPROXIMATELY 40 YOA WITH GRAY HAIR AND WAS AROUND 600/190. IP SAID MP GOT INTO A CAR WHICH WAS AN OLDER 95 BLUE OVER GRAY BLAZER ON 22" RIMS WITH THE SUBJECT AND LEFT. IP SAID THAT IS THE LAST TIME SHE SAW MP.

IP STATED SHE MADE A HARRASING TEXT REPORT OCPD #11-80563 IN REGARDS TO THE TEXT MESSAGES. RP STATES SHE IS TERRIFIED THAT SOMETHING HAS HAPPENED TO HER DAUGHTER. MP WAS LAST SEEN WEARING SOME GRAY VICTORIA'S SECRET PANTS WITH "PINK" WRITTEN ON THE BACK AND A WHITE MUSCLE SHIRT. MP ALSO HAS A TATTOO ON THE UPPER PART OF HER BACK THAT SAYS "QUEEN SPADE." MP ALSO HAS NUMEROUS CUT MARKS ON BOTH FOREARMS. I CONTACTED LT. MOSES #0570 AND ADVISED HIM OF WHAT I HAD AND HE AUTHORIZED A RADIOGRAM FOR A MISSING PERSON. LT. MOSES ALSO CALLED LT. DUGAN AND INFORMED HIM OF WHAT WE HAD.

LT. DUGAN REQUESTED THAT I HAND CARRY THE TEXT MESSAGES AND THIS REPORT TO HIM WHICH I DID. I MET WITH LT. DUGAN AND GAVE HIM THE COPY OF THE TEXT AND THE TWO PHOTOS I HAD OF MP. LT. DUGAN SAID HE WOULD FORWARD THEM ON TO A DETECTIVE.

I DID ASK IP IF THE SUBJECT SHE DID LAST SEE MP WITH WAS "SAVAGE" AND SHE SAID SHE HAD NO IDEA.
