J R JENCKS, affiant, being first duly sworn, on oath depose and state that the following constitutes evidence of commission of a crime.

A Pair of black Justin Roper cowboy boots of the "Roper" style, with white stitching design at the top and in red rubber on the bottom of the soles says "Justin J Flex", to be examined by the Oklahoma State Bureau of Investigation to include cutting samples from and taking parts of off to be examined for blood evidence DNA evidence and any other particulate or trace evidence that would associate the boots and the wearer with being present at the crime scene of the Carina Saunders murder.

That the above mentioned property is now located as follows:

At the Bethany Police Department Property Locker and being held as property number 12P88, associated with case number 11-8562, and being the property of Jimmy Massey.

in the City of Bethany, County of Oklahoma, State of Oklahoma based on the following facts.

Your affiant is a Police Lieutenant for the City of Bethany Police Department. That your affiant has 23 years of experience as a police officer in the State of Oklahoma. That your affiant has over 2500 hours of training through C.L.E.E.T. as well as a Bachelor's Degree in Criminal Justice and a Masters Degree in Management. That your affiant has worked in patrol, as a Detective, as a Supervisor and worked under cover narcotics. That your affiant has conducted over 2000 drug related investigations from initial investigation to undercover buys to search warrants to prosecution. That currently your affiant is assigned to the investigations division of the Bethany Police Department.

That your affiant has been assigned to investigate the homicide of Carina Saunders. That on November 4, 2011 Jimmy Massey was brought to the Bethany Police Department after his arrest on an arrest warrant for felony drug charges. That at the beginning of the interview Jimmy Massey was read his Miranda Rights from the BPD Form and he signed that he waived his rights and would talk to detectives and answer questions. That during the interview Jimmy Massey admitted that he was present at the scene and witnessed the torture and murder of Carina Saunders. That the investigation has revealed that Carina Saunders had massive blood loss during her torture and murder and that her body was then dismembered. That Massey was held at the Bethany Police Department that night and booked in and was given a set of jail clothes to wear. That while at the Bethany Jail Massey began to make medical complaints and was transported to the hospital for examination. That his clothing stayed at the Bethany Police Department and was logged into the property locker. That Massey was transported to the Oklahoma County Jail immediately after being released from the hospital.

That in talking with the wife of Jimmy Massey, Lori Massey, she stated

that the boots that Massey was wearing at the time of his arrest are the same boots that Massey wears the majority of the time. There is also considerable wear on the boots.

Therefore, I request a warrant to be issued directing the search of the above property for the above items.
